1. On August 5, 2014, the Commission served the Respondent with the Complaint filed in the above captioned matter, which is a billing dispute.
2. On August 25, 2014, PGW filed an Answer to the Complaint in the above captioned matter.
3. On December 8, 2014, PGW filed an Entry of Appearance for Laureto Farinas, Esq. in this matter.
4. By Notice dated December 17, 2014, the Commission scheduled an Initial Telephonic Hearing in this matter for Thursday, January 29, 2015 at 10:00 a.m., before Administrative Law Judge Mary D. Long.
5.
