**UNOPPOSED MOTION FOR CONTINUANCE**

TO ADMINISTRATIVE LAW JUDGE DAVID A. SALAPA:

Blue Pilot Energy, LLC (“BPE”), by and through its undersigned counsel, files this Motion for Continuance, pursuant to Section 1.15 of the Pennsylvania Public Utility Commission’s (“Commission”) regulations, 52 Pa. Code § 1.15, and in connection therewith avers as follows.

1. BPE submits this request for a continuance of the in-person evidentiary hearing scheduled for February 17, 2015 and for the rescheduling of that hearing on February 25, 26 or 27, 2015, depending upon the availability of the Administrative Law Judge (“ALJ”).

2. Merlin Barboza t/a R.K. Enterprise, Inc. (“Complainant”) has authorized BPE to represent that it has no opposition to this request, provided that the hearing is rescheduled within fourteen days. Additionally, the Complainant has confirmed its availability during the week of February 23, 2015.

3. Requests for continuance may be granted by the presiding officer “for good cause” under Section 1.15 of the Commission’s regulations, 52 Pa. Code § 1.15.

4. BPE’s only witness is Raymond Perea, General Counsel, and he is based in Las Vegas, Nevada. Due to pre-existing professional and personal commitments, Mr. Perea is not available to travel on February 16, 2015 in order to provide in-person testimony on February 17,


2015. His schedule does, however, allow him to travel during the week of February 23, 2015, with the only limitation being that he is currently scheduled to testify in a telephonic hearing on February 24, 2015 at 1:00 p.m. in the matter of *Yaglidereliler Corporation v. Blue Pilot Energy, LLC*, Docket No. C-2014-2413732. Therefore, if this Motion is granted and there is any flexibility in choosing an alternate date and time among those that have been suggested, BPE would appreciate consideration being given to Mr. Perea's inability to travel while offering his telephonic testimony on February 24, 2015.

5. Therefore, for good cause shown, BPE respectfully requests that the evidentiary hearing scheduled for February 17, 2015 be continued and rescheduled to February 25, 26 or 27, 2015.

WHEREFORE, Blue Pilot Energy, LLC respectfully requests that Your Honor grant this Motion for Continuance of the February 17, 2015 Evidentiary Hearings and reschedule them during the week of February 23, 2015.


