Dear Secretary Chiavetta:

I am writing this letter as a request for a three month extension of time to respond to the Notice to Plead, dated December 29, 2014 (mailed on December 31, 2014,) and submitted by Graciela Christlieb, Esquire, on behalf of the Philadelphia Gas Works. I am currently in Florida and have been since December 18, 2014; originally planning to return to Philadelphia on December 26, 2014. However, on December 20, 2014 my Mother fell and fractured her femur. This has required hospitalization, surgery, rehab and the need to place two almost 90 year old adults in a licensed care facility. This decision to place these two adults in a care facility was determined by an elder care case worker. Accordingly, all of this unanticipated responsibility has fallen entirely on my shoulders and by its nature, is both time consuming and complicated.

Due to my unexpected stay, a sympathetic neighbor has sent me my mail, specifically including the Notice to Plead which I did receive on January 10, 2015. However, my computer and all my documentation is in Philadelphia and outside my ability to retrieve, even this letter was done by a family acquaintance. As a result, I cannot respond in an informed way to the Notice. Additionally, I do not know how soon I will return to Philadelphia, even though at this time I plan to return on January 22, 2015.

Due to these extenuating circumstances, I am asking for your consideration of a three month extension of time to respond.
