Commonwealth Telephone Company dba Frontier Communications
Commonwealth Telephone Company ("CT") and Sprint Communications Company L.P.
("Sprint") hereby request that the Commission review and approve the attached Interconnection
Agreement pursuant to Sections 252(a)(1) and 252(e) of the Telecommunications Act of 1996
47 U.S.C. §§ 252(a)(1) and 252(e) (the "Act"). In support of their request, the parties state as
follows:

1. The Agreement was arrived at through good faith negotiations between the
parties as contemplated by Section 252(a) of the Act and provides for interconnection as
addressed in Section 251 of the Act.

2. Pursuant to Section 252(e)(2), the Commission may only reject a negotiated
Agreement if it finds that (1) the Agreement discriminates against another carrier or (2)

implementation of the Agreement would not be consistent with the public interest, convenience and necessity.

3. CT will make the Agreement available to any other telecommunications carrier operating within its territory. Other carriers are also free to negotiate their own terms and conditions pursuant to the applicable provisions of the Act. For this reason, the Agreement is not discriminatory.

4. In addition, implementation of the Agreement is consistent with the public interest because it will promote competition and enhance Sprint's ability to provide Pennsylvania telecommunications users with a competitive alternative for telecommunications services.

5. In accordance with Section 252(e)(4) of the Act, the Agreement will be deemed approved if the Commission does not act to approve or reject the Agreement within 90 days from the date of this submission.


6. Copies of the Agreement are available for public inspection in CT and Sprint's public offices.


