On January 12, 2015, counsel for Energy Services Providers, Inc. d/b/a Pennsylvania Gas & Electric ("PaG&E") sent you a Notice of Deposition by Written Questions and Deposition in connection with the written testimony you provided to the Office of Attorney General ("OAG") and the Office of Consumer Advocate ("OCA") for use in their complaint proceeding against PaG&E before the Pennsylvania Public Utility Commission ("Commission").
