AND NOW, comes BR Moving LLC (hereinafter “Applicant”) and Adam Meyer, Inc., Advance Transportation Co., Inc., Clemmer Moving & Storage, Inc., Hughes Relocation Services, Inc., Fisher-Hughes of Allentown, Inc., Frick Transfer, Inc., Glose Moving & Storage, Inc., Glose Moving & Storage, Inc. d/b/a O’Brien’s Moving & Storage, Inc., Charles Groff & Sons, Inc., Keller Moving & Storage, Inc., Reads Van Service, Inc., Shively’s Moving & Storage, Co., and Jack Trier, Inc. (hereinafter “Joint Protestants”) and file this restrictive amendment as follows:

1. The above-captioned application is hereby amended as follows:

To transport as a common carrier, household goods in use, between points in the city and county of Philadelphia and from points in the city and county of Philadelphia to points in Bucks, Chester, Delaware and Montgomery counties in Pennsylvania.

2. Based upon the Restrictive Amendment set forth in Paragraph 1 above, and conditioned upon its acceptance by the Pennsylvania Public Utility Commission (the “Commission”), any order issued being consistent therewith, Joint Protestants agree to withdraw their Joint Protest to the Application as amended. Joint Protestants desire to remain parties of record so as to receive copies of any order issued by the Commission in this proceeding.

3. If the Restrictive Amendment is not accepted by the Commission, the parties agree that further hearings shall be held to permit Joint Protestants to present evidence in opposition to approval of the Application.


