Please accept my apology for not filing proper notification to PUC concerning the closing of my van business. I did not realize that I had to file this paper work with PUC.




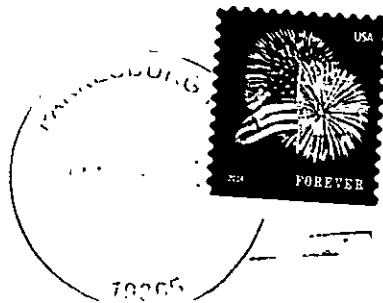
