SECTION 1  
RULES AND REGULATIONS

ITEM 10 - DECLARED VALUE

Rates and charges named herein applicable when the value declared by shipper does not exceed sixty (60) cents per pound per article. For method of determining rates when declared value exceeds sixty (60) cents per pound per article, see Governing Tariff.

ITEM 20 - ADVANCED RESERVATIONS

Advanced reservations must be given prior to services being rendered.

ITEM 30 DEPOSITS AND CANCELLATION POLICY

All reservations require a \$200.00 deposit per truck per day requested. This deposit is refundable up to 72 business hours prior to the service date. Within the 72 hour cancellation period and the service date the deposit is non-refundable. All deposits must be received within 48 hours at the time the reservation was made.

ITEM 40 - ADDITIONAL EXPENSES

All tolls, parking fees, and other out-of-pocket expenses will be the responsibility of the customer and added to the carrier's charges.

ITEM 50 - HOURLY RATES

Hourly rates begin from the time the vehicle/personnel leaves the carrier's place of business and ends at the time the vehicle/personnel returns to the carrier's place of business. All charges are calculated into one-half ( $\frac{1}{2}$ ) hour increments and rounded up to the next one-half ( $\frac{1}{2}$ ) hour.

ITEM 60 - PIANOS, ORGANS, GRAND FATHER/MOTHER CLOCKS, GUN CABINETS

When a piano, organ, grand father/mother clock and gun cabinets weighing up to 800 pounds are a part of the shipment, carrier will assess the following charges in addition to the applicable hourly rates published herein.

Gun Cabinets .....	25.00

SECTION 3  
HOURLY RATES

ITEM 300

Applicable on the transportation of household goods in use transported distances of forty (40) miles and less.

Subject to Notes 1 to 6 below, the transportation charge on any shipment shall be a combination of the applicable traveling charge in Column 1 plus hourly charge at applicable rates named in Columns 2, 3 and 4.

Hourly rates apply from time of departure from our facility located at 1 Bellecor Drive, New Castle, DE 19720 and continue until the travel charge back to facility 1 Bellecor Drive, New Castle, DE 19720.

Note 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4)

Note 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days, as indicated during which services are performed.

Note 3 - Hourly rates (Columns 2, 3 and 4) computed in half-hour periods; fractions of one-half hour considered one-half hour.

Note 4 - When a holiday falls on a Saturday the rates named in Columns 1 and 2 shall apply.

Note 5 - Minimum total transportation charges:

(a) Column 2 will apply a four (4) hour minimum.

(b) Column 3 will apply a two (2) hour minimum.

(c) Column 4 will apply a three (3) hour minimum.

Note 6 - All hourly charges start at the time of our departure from our facility located at 1 Bellecor Drive, New Castle, DE 19720. The charges will continue until the estimated travel time back to our facility at 1 Bellecor Drive, New Castle, DE 19720.
