

Dues shall be paid annually. Members shall be billed proportionately when participation period is not for a full year. If any member does not pay within 60 days of expiration of his previous year's dues, the Treasurer shall notify the Administrative Officer of said delinquency and participant will be allowed 30 days from such notification by Treasurer in which to comply. If, after the 30 days there has been no compliance, then the Conference shall cancel said membership and notify any and all governing agencies of such cancellation.
