## JOINT PETITION

Comcast Phone of Pennsylvania, LLC d/b/a Comcast Digital Phone ("Comcast Phone"), a competitive local exchange carrier ("CLEC") and Cellco Partnership d/b/a Verizon Wireless ("Verizon Wireless"), a commercial mobile radio service ("CMRS") provider (collectively, the "Parties"), pursuant to In Re: Implementation of the Telecommunications Act of 1996, Docket No. M-00960799 (Order entered on June 3, 1996; Order on Reconsideration entered on September 9, 1996); see also Proposed Modifications to the review of Interconnection Agreements (Order entered on May 3, 2004) (the "Implementation Orders"), and to the extent applicable. Section 252(e) of the Communications Act of 1934, as amended (the "Act"), 47 U.S.C. § 252(e), hereby jointly submit to the Pennsylvania Public Utility Commission ("Commission") an Interconnection and Reciprocal Compensation Agreement for Commercial

The following Verizon Wireless entities are also parties to the Interconnection Agreement: Allentown SMSA Limited Partnership, Northeast Pennsylvania SMSA Limited Partnership, Pennsylvania 3 Section 2 Limited Partnership, Pennsylvania 4 Sector 2 Limited Partnership, Pennsylvania RSA 1 Limited Partnership, Pennsylvania RSA 6 (I) Limited Partnership, Pennsylvania RSA No. 6 (II) Limited Partnership, Pittsburgh SMSA Limited Partnership and Verizon Wireless Power Partners Inc., all CMRS providers.

Mobile Radio Service (CMRS) (the "Interconnection Agreement") for review and approval.<sup>2</sup> In support of this joint petition, Comcast Phone and Verizon Wireless state as follows:

- 1. The Parties have entered into good faith negotiations and have executed an interconnection agreement. The Interconnection Agreement was fully executed as of January 5, 2006. A copy of the Interconnection Agreement, duly executed by the Parties, is submitted with this joint petition as **Attachment A.**
- 2. The Interconnection Agreement establishes arrangements for the exchange of Local and IntraMTA traffic between the Parties in Pennsylvania. In addition, the Interconnection Agreement provides the terms for interconnecting the Parties' networks and establishes reciprocal compensations arrangements for Local and IntraMTA traffic. The Interconnection Agreement carries a term of two years.
- 3. In accordance with Section 252(e) of the Act, the Commission is charged with approving or rejecting a negotiated Interconnection Agreement within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier who is not a party to the agreement or the implementation of the agreement or any portion thereof is not consistent with the public interest, convenience and necessity.
- 4. The Interconnection Agreement was voluntarily negotiated and agreed to by Comcast Phone and Verizon Wireless, and does not discriminate against a telecommunications

While it is not clear that Section 252 applies to interconnection agreements such as the one between the Parties, out of an abundance of caution, and without waiving any right to assert that the agreement is not subject to the jurisdiction of the Commission, the Parties submit their Interconnection Agreement for Commission review. See Qwest Communications International Inc. Petition for Declaratory Ruling on the Scope of the Duty to File and Obtain Prior Approval of Negotiated Contractual Arrangements under Section 252(a)(1), WC Docket No. 02-89, Memorandum Opinion and Order, 17 FCC Rcd 19337, 19341-42 (2002)(noting the role of the state commissions to determine which agreements require filing for approval).

carrier not a party to the Interconnection Agreement. Approval of the Interconnection Agreement is consistent with the public interest, convenience and necessity.

WHEREFORE, Comcast Phone, LLC and Cellco Partnership d/b/a Verizon Wireless jointly request Commission approval of the Interconnection Agreement pursuant to the *Implementation Orders* and Section 252(e) of the Act as expeditiously as possible.


