INDEPENDENT CONTRACTOR OF ENERGY AGREEMENT "ICE"

This Independent Contractor of Energy Agreement ("Agreement") is dated and effective this ___ day of _____, 20___, New America Power, a Pennsylvania LLC, with offices at 41 University Dr, Suite 400, Newtown PA, 18940 ("NAP") and _____ a _____, with offices at _____ (Independent Contractor of Energy Procurement "ICE")

WHEREAS, NAP is an energy broker and consultant in the business of energy procurement (natural gas and electricity), and ICE is in the business of **Energy sales** and Energy consulting for commercial and industrial facilities.

WHEREAS, the Parties desire to agree to enter into this Agreement to set forth the terms and conditions pursuant to which ICE will provide services to and for NAP;

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth and subject to the terms and conditions contained herein, the Parties agree as follows:

1. Responsibilities of ICE

- (a) ICE shall use its best efforts to find, generate sales leads, and analyze prospective customer's **energy options**. ICE shall present NAP quotes to prospective customers, implement the actions necessary to consummate **the sales contract and/or energy contract**, and retain good ongoing relations with the customer to retain customer satisfaction and a contract renewal. ICE shall pay all expenses associated with all of its activities and sales and marketing efforts, including, without limitation, all expenses and compensation of its representatives and personnel and all its related administrative and overhead expenses.
- (b) For each prospective customer, ICE shall submit to NAP, at a minimum, the New Customer Profile which includes the customer contact and credit information (SS or EIN) electric or natural gas usage history, along with one utility invoice per meter, or other utility provided format. NAP shall have no obligation to accept or use information from sources other than the prospective customer's local distribution company, or from the prospective customer itself. NAP shall notify ICE of any missing or inaccurate data, and ICE shall be responsible for immediately contacting the prospective customer to obtain or correct such missing or inaccurate data. NAP shall have no obligation to process any documentation without all necessary customer data.
- (c) ICE shall not pay, offer or promise to pay, or give any money or anything of value, directly or indirectly, to any prospective customer, any officer or employee of a government, or any department or agency thereof, or to any political party or candidate for political office for the purpose of inducing any such person, official, party or candidate to misuse its position or to influence any act or decision of a government in order to obtain, retain or direct business to or otherwise influence a decision in favor or for the direct or indirect benefit of ICE of NAP, in violation of any applicable laws.
- (d) **After an energy contract** is signed, ICE shall provide such other services, which are necessary and appropriate for the administration of each customer's account.
- (e) ICE shall at all times act in a professional and workmanlike manner.

- (f) ICE shall supply all tools and instrumentalities required to perform its obligations under this Agreement.
- (g) ICE shall be responsible for compliance with all applicable federal, state and municipal laws, statutes and ordinances that may apply to the performance of ICE's obligations under this Agreement. Further, ICE agrees to hold harmless and indemnify NAP for any claims, demands, liabilities and costs arising out of ICE's failure to abide by any applicable law, statute, ordinance or regulation.

2. Designated Market

- (a) The activities of ICE with respect to NAP products and services shall be limited to the specific geographical market territory and specific market segmentation identified in Exhibit A attached hereto and made a part hereof (the "Designated Market").
- (b) ICE's appointment shall be on a non-exclusive basis, and NAP reserves the right, in its sole discretion, to appoint other representatives both in and outside of the Designated Market. ICE acknowledges that NAP own direct sales and other approved independent contractors of **energy** may market in the Designated Market. NAP and ICE acknowledge that circumstances may require flexibility in the Designated Market and, as a result, the parties shall mutually agree to alter the Designated Market as necessary.
- (c) ICE shall become licensed or certified, if required, in the Designated Market, shall bear any costs associated with such license or certification, and shall provide evidence of same to NAP.

3. Customer Referral

- (a) NAP reserves the right, in its sole discretion, to determine whether or not to enter into an **energy** agreement with a prospective customer identified by ICE. Criteria for such determination may include the prospective customer's annual energy usage, energy usage load factor, the prospective customer's financial condition, and market conditions. NAP shall provide ICE with general guidelines for acceptable customers, recognizing, however, that NAP shall make the final determination regarding acceptability for **all sales**.
- (b) ICE shall obtain and submit, in typed form, the information set forth in Section 1(b), pricing preferences, invoicing structure and starting date, and shall notify NAP of the existence of telemetry equipment, expiration date of existing supply contracts, and any other information relevant to the success of securing a **energy** contract with such prospective customer.
- (c) Upon receipt of the pricing and credit approval from NAP, ICE shall ensure that NAP **energy** contract agreements are accurately and legibly completed in full by the prospective customer including, but not limited to, all required signatures, titles, dates and other required contract information, for presentation to NAP. ICE shall have no authority to, and shall not, bind NAP or any of NAP suppliers to any agreement, obligation or representation.

4. Calculation and Payment of Compensation

- (a) NAP will establish in writing a base price ("Base Price") for sales to prospective business customers identified by ICE. The ICE sets its commission based on mils added to base. The ICE receives **60%** of total commission.

- (b) There is no termination compensation for any development of goodwill or otherwise due to ICE hereunder. After termination of this Agreement, subject to the terms hereof, and because of investments made both in time and money, expended by ICE, to develop customers and clients, ICE shall continue to earn a commission for sales under *Eligible Contracts entered into during the term of this Agreement*. ICE shall not be entitled to any other compensation or payment upon termination.

Notwithstanding the foregoing, in addition to other rights and remedies available to NAP, ICE shall immediately forfeit any accrued commissions, its right to any future commissions, and any other amounts due to it hereunder, and NAP shall have no obligation to pay any of such amounts, if NAP terminates this Agreement for any of the following reasons:

- (i) the taking of any action beyond the scope of ICE's authority, including, without, limitation, representing to third parties that ICE has the ability to bind NAP and/or any action taken by ICE that binds NAP;
- (ii) the failure to comply with any provision of Section 9 hereof;
- (iii) the failure to comply with any provision of Section 1(c) hereof;
- (iv) the unauthorized use of advertising materials or medium;
- (v) the alteration of customer usage data;
- (vi) the enrollment of a customer with the local distribution company by the ICE;
- (vii) the collection from a customer of amounts due to NAP;
- (viii) the arrest of ICE or any its key personnel for a crime; or
- (ix) the breach of the duties of loyalty and confidentiality, including, without, limitation, improper divulgence of pricing information. NAP also reserves the right to set-off any damages for breach of this Agreement against any amounts owed to ICE.

- (c) ICE shall not invoice or attempt to collect any amounts from any customer; provided that ICE shall assist NAP in its collection efforts, and after consultation with NAP, ICE may inquire about the status of payments.

If the customer fails to pay the full amount of any invoice for whatever reason, NAP retains the right, in its sole discretion, to settle or otherwise accept less than full payment from any customer, in which case the commission will be based on such reduced amount as it pertains to energy procurement.

|

- (d) Notwithstanding anything to the contrary in this Agreement, ICE shall not be entitled to any commissions relating to any portion of a customer **energy** contract that has been terminated by the customer before its scheduled expiration date.
- (e) ICE and its agents shall be solely responsible for the payment of any income taxes or other taxes imposed upon the compensation paid under this Agreement. NAP has no obligation to compensate ICE or its agents for, or *withhold any of, such taxes.*

5. Additional Independent Contractors of **Energy**: No Assignment

- (a) ICE may expand its sales capabilities by contracting with its own sub-representatives. ICE shall be solely responsible for any sub-representatives, including payment of any and all compensation, reporting, and quality of service and ICE shall be liable for and shall indemnify and hold NAP harmless from and against any acts or omissions of sub-representative in violation of the terms and conditions of this Agreement.
- (b) *No portion of the services to be provided by ICE hereunder may be directly or indirectly subcontracted, assigned, delegated or performed by ICE without prior written approval of NAP, which approval may be withheld in NAP sole discretion. Nothing herein, however, shall limit ICE's use of administrative and support staff to assist it in executing its responsibilities under this Agreement.*
- (c) This Agreement is binding on the successors and permitted assigns of the respective parties. Any transfer or assignment in violation of this Agreement shall be null and void.

6. Restrictions on Activities

- (a) NAP success depends upon its reputation as a high quality service oriented company and on customer satisfaction. ICE shall not engage in any activity, which could harm the business reputation of NAP relationships with existing and prospective customers and suppliers. Mass email marketing (spam), unsolicited mass telemarketing, mass faxing (fax blasting) and any other mass marketing that is a public nuisance is strictly forbidden. NAP shall be the sole judge of whether ICE's activities are harmful to NAP interests and ICE shall comply with all requests of NAP to desist from any such activities.
- (b) During the term of this Agreement, ICE may choose to represent, and market for, companies that provide the same or similar products and services as NAP within the Designated Market. However, ICE shall notify NAP of any activity, employment, or business arrangement now existing or later contemplated or occurring that may conflict or compete with the interests of NAP and NAP reserves the right, upon 30 days' prior written notice to ICE to terminate this Agreement if ICE continues such activities. ICE represents and warrants that its performance under this Agreement does not and shall not violate or breach any agreement, including, but not limited to, any service contract, employment contract, non-competition agreement or non-solicitation agreement to which ICE is a party.
- (c) At all times during the term of this Agreement and continuing thereafter, ICE shall treat as proprietary and confidential, and shall not disclose or use for any purpose, except in the performance of this Agreement, any confidential information (including, without limitation, pricing, preferences, financial information or business strategy) belonging to a customer, NAP, or any third parties disclosed to ICE in connection with this Agreement.

- (d) During the term of this Agreement, it is imperative that the integrity of information remains intact. ICE shall communicate directly with NAP and shall not circumvent NAP to work directly with individual energy suppliers utilized by NAP. Information flows from supplier to NAP to ICE and then to customer, and ICE understands and agrees that all communication flows up and down the supply chain accordingly for seamless understanding.
- (e) ICE agrees that, for a period of twelve (12) months after termination of this Agreement, ICE will not, directly or indirectly, individually or in concert with others, (i) use confidential information (as defined in subparagraph (c) of this Section) to induce or attempt to induce any customer or prospective customer to discontinue as customer of NAP or to become a customer of ICE or any other person or entity or (ii) induce or attempt to induce any employee or independent contractor of NAP to discontinue as an employee or independent contractor of NAP or to become an employee, partner, co-owner, independent contractor or enter into any similar relationship with ICE or any other person or entity.
- (f) ICE will not pursue a relationship with NAP's energy suppliers for a term of 1 year from the termination of this agreement.

7. Termination

This Agreement may be terminated by either party, for any reason and at any time, by providing to the other party sixty (60) days' prior written notice of its election to terminate this Agreement; provided that (a) this Agreement shall automatically terminate if a party becomes insolvent, has bankruptcy proceeding filed by or against it, or ceases to conduct business in the ordinary sense; (b) NAP may terminate this Agreement immediately by written notice to ICE if (i) ICE dies; (ii) ICE or any of its officers or key personnel is arrested for a crime, (iii) ICE submits any false information in connection with this Agreement or the performance of its obligations under this Agreement; (iv) ICE or any of its officers or key personnel take any action (or inaction) that, in any way, has an adverse effect on NAP reputation; or (v) management or ownership of ICE changes; (c) NAP may terminate this Agreement as provided in Section 6(b); and (d) either party may terminate this Agreement upon thirty (30) days' written notice to the other party if the other party breaches this Agreement and such breach is not cured by the end of the thirty-day notice period.

8. Duration of Agreement

This Agreement will be in effect for an initial period of two (2) years from the date of execution by NAP. Unless either party has notified the other to the contrary, this Agreement shall continue on a month to month basis after the expiration of such initial term, but either party may terminate this Agreement upon fifteen (15) days' prior written notice during such renewal period. ICE shall return all marketing materials belonging to NAP within three (3) business days after termination of this Agreement for any reason and shall not retain any copies or reproductions thereof (whether hard copy, digital format or otherwise) of any such materials.

9. Independent Contractor Status

- (a) It is understood and agreed, and it is the intention of the parties hereto, that ICE is an independent contractor, and not the employee or agent of NAP for any purpose whatsoever. ICE shall be responsible for achieving the standards established by NAP. However, NAP shall have no right to and shall not control the manner, or prescribe the method, of accomplishing the services to be performed by ICE under this Agreement. ICE shall have no authority to act for or on behalf of NAP, or to bind NAP to any contract, representation, or any other matter. ICE shall not express or imply the contrary to any third party. Nothing contained herein shall be deemed or construed to create any employment relationship or any partnership or joint venture between NAP and ICE or its agents.
- (b) As an Independent Contractor ICE understands and agrees that no rights will accrue to it or its employees, representatives or agents under any pension, bonus, profit sharing, savings, insurance, health, vacation, or other plan or arrangement generally offered by NAP to its employees.

(c) NAP and ICE agree to indemnify each other and their officers, directors, employees and affiliates from and defend and hold each of them harmless against any liabilities, claims, suits, demands, expenses (including, without limitation, reasonable attorneys' fees and costs and expert witness fees and costs) and costs arising out of acts or omissions, of each, in connection with the activities contemplated hereunder, including, without limitation, any breach of this Agreement or any statements in contravention of this Agreement.

10. Trademarks, Service marks and Trade names

- (a) NAP may provide ICE with sales and marketing materials, such as brochures and fact sheets. ICE shall not (i) use any other marketing materials, other than those provided by NAP for NAP services, and shall not (ii) use the name NAP or the relationship of the parties hereunder, unless, in each specific instance, NAP has authorized in writing such marketing and/or publicity. In addition, ICE shall obtain NAP written approval, in advance, to all advertising, promotional materials, letterhead, and business cards proposed to be used by ICE in connection with ICE's activities under this Agreement.
- (b) NAP grants to ICE the limited right, during the term of this Agreement, to use the trademarks, trade names, service marks of NAP (collectively, the "Marks") solely in connection with the promotion and sale of the products and services of NAP, provided that such Marks are clearly identified at all times as marks of NAP, and further provided that ICE receives the specific written approval of NAP for each proposed use of such Marks in advance of such use. ICE shall not at any time use the Marks as part of its company name, trade name, trademark, service mark or internet address. ICE acknowledges NAP ownership of the Marks and the goodwill associated therewith, and agrees that all goodwill resulting from the ICE's use of the Marks will inure solely to the benefit of NAP.

11. Miscellaneous Provisions

- (a) If any provision or portion of this Agreement is determined to be illegal or unenforceable by a court or any regulatory agency with competent jurisdiction, the remainder of this Agreement shall remain in full force and effect and shall not be rendered illegal, unenforceable or otherwise affected by such disposition; provided, however, that if the invalidity, illegality or inability to enforce any such provision results in a material alteration of the terms of this Agreement, the remaining provisions of this Agreement shall be adjusted equitably so that no party benefits disproportionately. Either party's failure to insist upon strict performance of any provision herein shall not constitute a waiver of, or estoppel against asserting, the right to require such performance in the future.
- (b) Any notice or other communication between the parties shall be in writing and shall be (i) delivered in person, (ii) sent by facsimile (with confirmation), or (iii) sent by an nationally recognized courier service (with shipping costs prepaid for priority delivery and return receipt requested), in each case at the address first set forth above or otherwise so specified by such party from time to time. All such communications shall be deemed to have been received on the first to occur of (A) the date actually delivered in person to such address, (B) the date sent by facsimile if confirmation of receipt thereof is received by the sending person, or (C) two (2) business days after delivery to such courier.
- (c) This Agreement (including all Exhibits hereto) constitutes the entire agreement between the parties concerning the subject matter hereof. All other proposals, agreements, or representations, whether oral or written, are hereby superseded. This Agreement may be changed, modified or otherwise amended (in whole or in part) only by an instrument in writing signed by an authorized representative of each party, except that NAP reserves the right to modify this Agreement upon written notice to ICE in the event of material changes in applicable laws or regulations.
- (d) Unless otherwise prohibited by law or specified below, any dispute arising hereunder or relating hereto shall be resolved by arbitration pursuant to the commercial rules of the American Arbitration Association ("AAA").

Such arbitration shall involve a single arbitrator (selected by the parties, or in the absence of agreement, appointed by the AAA), and shall take place in Montgomery County, PA. The arbitrator shall apply Pennsylvania law, without regard to principles of conflicts of law. The arbitration decision shall be binding upon the parties and judgment upon the award may be entered in any court having jurisdiction over the party against which enforcement is sought. The cost of the arbitration shall be paid in a manner determined by the arbitrator. Notwithstanding the foregoing, (i) each party reserves the right to seek specific performance or any other form of injunctive or equitable relief in the Montgomery County Court of Common Pleas for purposes of enforcing this Section and (ii) ICE acknowledges and agrees that the remedy at law for breach of Section 6 (Restrictions on Activities), 8 (Duration of Agreement) and 10 (Trademarks, Service Marks and Trade Names) shall be inadequate and that, in addition to all other remedies, NAP reserves the right to seek specific performance or any other form of injunctive or equitable relief in the Montgomery County Court of Common Pleas for purposes of enforcing Sections 6, 8 and 10.

- (e) Neither party shall be responsible for any incidental, indirect, consequential, special, punitive, or exemplary damages of any kind.
- (f) The interpretation and performance of this Agreement shall be in accordance with, and controlled by, the laws of the Commonwealth of Pennsylvania, without regard to principles of conflicts of law.
- (g) This Agreement shall not benefit any third party and may only be enforced by the parties, or any permitted assignee. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute but one and the same instrument. Facsimile signatures shall be deemed original Signatures.

All notices required or allowed to be given under this Agreement will be given to the other party at the address set forth below, or to such other address as either party may instruct the other party in writing.

II. Code of Conduct for Energy Sales Representatives

2. Representatives will not state, imply, or knowingly allow the prospective customer to believe, that they are a representative of the local utility or any other retail electric provider.
3. Representatives will make no representations or statements that the perspective customer must switch in order to continue receiving power.
4. Representatives will not make any verbal representations regarding, contracts, rights, or obligations unless those representations are contained in the offer.
5. Representatives will not make any verbal or written representations regarding guaranteed savings to the customer.
6. Representatives will not attempt to enroll any business unless they have obtained confirmation from the person with whom they are speaking that they are authorized to make decisions on behalf of the business.
7. Representatives will not place undue pressure on a prospective customer in order to enroll them.
8. Representatives will not "slam" a prospective customer, which is the act of causing their electricity service to be switched without their consent.
9. Representatives understand that they must treat all prospective customers with respect and maintain an appropriate degree of professionalism as established by New America Power.
10. Representatives understand that use of, or being under the influence of, drugs or alcohol while representing New America Power will result in immediate revocation of authority to represent New America Power any longer.
11. Representatives agree to comply with all applicable PUC/PSC regulatory guidelines specific to the sale of retail electricity and the method in which the customer is marketed to.
