PPL ELECTRIC UTILITIES CORPORATION'S COMMENTS


AND NOW comes the Respondent, PPL Electric Utilities Corporation ("PPL"), by and through its attorneys of record, Gross McGinley, LLP, and files the within Comments, alleging in support thereof as follows:

1. On August 14, 2014, Alfredo Caraballo, filed a formal Complaint against PPL Electric Utilities Corporation ("PPL Electric") seeking a payment arrangement. An Answer of PPL Electric was filed on September 23, 2014. An Initial Decision was then issued by ALJ Colwell on December 17, 2014. Complainant then filed Exceptions on December 26, 2014, to which PPL Electric filed Replies on January 7, 2015. Since that time, Complainant has become eligible for the OnTrack Program. In fact, Respondent, PPL Electric, has continued to work with Complainant, and Complainant has been re-accepted into the OnTrack Program. Complainant's first bill under the OnTrack

Program, in the amount of \$143, is due March 4, 2015. Accordingly, Mr. Caraballo is a current participant in the OnTrack Program.
