

MOTION FOR DEFAULT JUDGMENT


NOW COMES the Pennsylvania Public Utility Commission's (Commission) Bureau of Investigation and Enforcement (I&E), by its prosecuting attorneys, and files this Motion for Default Judgment against Yellow 2000 of Philadelphia Inc. (Respondent) pursuant to Section 5.103 of the Commission's regulations, 52 Pa. Code §5.103. In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on October 27, 2014 by filing a Complaint.
2. On October 28, 2014, the Complaint was served by certified mail to Respondent at 1405 West Pike Street, Philadelphia, PA 19140.
3. This is the last known mailing address that Respondent provided to the Commission.
4. While there is no record that the Complaint was returned to the Commission, I&E was unable to obtain certification that Respondent received the Complaint.
5. Pursuant to the Commission's procedural regulations at 52 Pa. Code §1.53(e), the Complaint was published in the Pennsylvania Bulletin on January 24, 2015. *See 45 Pa. Bull.* 480 (January 24, 2015).
6. Included with the Complaint was a Notice advising Respondent that it must file an Answer within twenty (20) days.

7. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.
8. Respondent did not file an Answer to the Complaint.
9. Pursuant to Section 5.61(c) of the Commission's regulations, a Respondent who fails to file an Answer to a Complaint within the 20-day response period may be deemed in default, and the relevant facts stated in the Complaint may be deemed admitted. 52 Pa. Code §5.61(c).
10. The Commonwealth Court has upheld the Commission's authority to sustain complaints that are not answered within twenty days. *See Fusaro v. Pa. PUC*, 382 A.2d 794, 797 (Pa. Cmwlth. 1978).
11. Respondent did not pay its outstanding assessment balance of \$308 or the \$1,046 civil penalty that was requested in the Complaint for Respondent's failure to pay the Commission's assessment for the 2013-2014 fiscal year and file an assessment report demonstrating its 2012 calendar year revenues.
12. I&E respectfully requests that the Commission enter a Default Order against Respondent that:
 - a. Directs Respondent to pay its outstanding assessment of \$308 for the 2013-2014 fiscal year and the requested civil penalty of \$1,046 within thirty (30) days of the entry date of the Commission's Order;
 - b. Directs the Bureau of Technical Utility Services to cancel Respondent's certificate of public convenience at A-00115790 if the assessment and civil penalty are not timely paid;
 - c. Notifies Respondent that a copy of this Order will be sent to the Pennsylvania Department of Transportation for the suspension or revocation of vehicle registrations that were used under Respondent's operating authority; and

- d. Directs the Bureau of Administrative Services, Assessment Section to refer the matter to the Pennsylvania Office of Attorney General for collection of the unpaid assessment.


