- (b) Where storage-in-transit shipment is not unloaded at carrier's warehouse, and shipment remains on carrier's vehicle, an overnight S.I.T. flat charge of \$200.00 per vehicle will be assessed.
  - (c) Waiting charge will be assessed by carrier on the basis of a vehicle, driver and two helpers at the applicable hourly rates shown above from 8 A.M. following overnight S.I.T. flat charge <u>until</u> carrier's employees and equipment arrive at customer's location for unloading. Thereafter, carrier's hourly rates above will be assessed based on the equipment and labor furnished by carrier from the commencement of unloading until completion of unloading and dismissat of equipment and labor by shipper.
