Computation of Hours

Except as otherwise specifically provided herein, the hourly rate shall be computed from the time the vehicle leaves the carrier's garage until the vehicle returns to the carrier's garage.

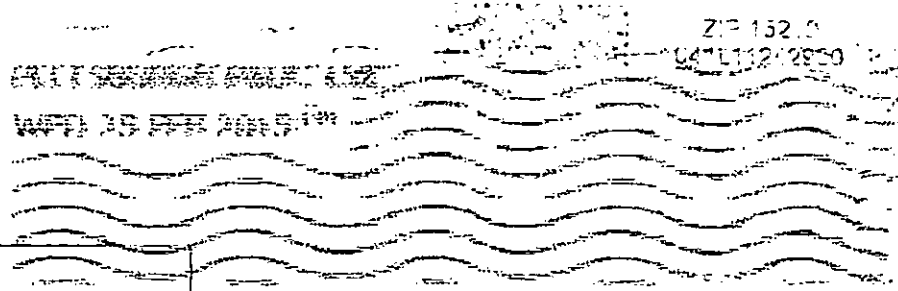
