1. The name and address of applicant are Commonwealth of Pennsylvania, Department of Transportation, Mark J. Chappell, P.E., Chief, Utilities and Right-of-Way Section, PO Box 3362, Harrisburg, PA 17105-3362.

3. The applicant is an agency of Commonwealth of Pennsylvania, organized and existing under the Administrative Code of 1929, 71 P.S. § 511, et. seq. and generally 36 P.S. § 670 - 401 et. seq.

6. SR 0062 (Petroleum Street), Section S02, crosses at-grade the single track of Western New York & Pennsylvania Railroad, LLC and said crossing should be altered as indicated. The crossing is located at Segment 0470, Offset 0168. The ADT for SR 62 is 10175 vehicles with 7% trucks.
7. The Department agrees to reimburse Western New York & Pennsylvania Railroad for its actual design and construction costs with 100% Federal Funds. The estimated construction cost of the new warning devices is \$309,000.
8. This project is necessary and proper for the safety and convenience of the public.

9. A conference of all parties of interest should be held to discuss the proposed improvement.

Wherefore, applicant respectfully requests that the Public Utility Commission approve the application.



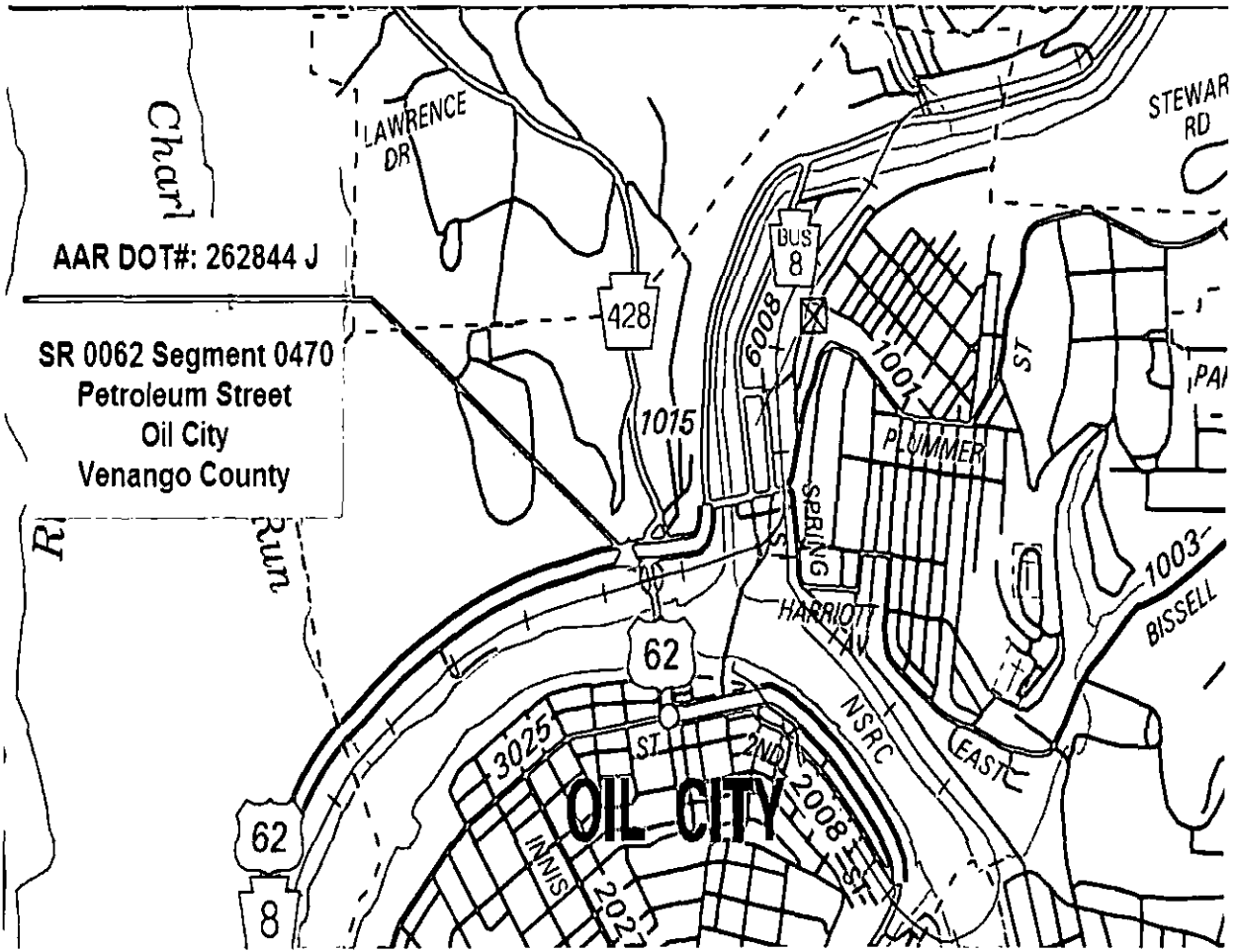


