1. Operating authority amended per Commission order entered January 2, 2015, (A-121368. Dockets A-2014-2444235 & A-2014-2443863). These additional rights, are rights owned by Quakertown Taxi LLC A-6311317 and were originally granted under Docket Number A-2009-2126367 and as amended under Docket Number A-2012-2312893.
2. Initial rate was raised to \$3.95 for the First 1/5 mile or fraction thereof, from \$3.70 for the First 1/5 mile or fraction thereof.
3. Waiting time was raised to \$0.46 for every 50 seconds, from \$0.46 for every 75 seconds.

To transport, as a common carrier, by motor vehicle, persons, upon call or demand in the township of Solebury, and the borough of New Hope, and that portion of Bucks County located south and east of Pa. Route 232; and that portion of Montgomery County located north and west of Pa. route 73.

A-00121368, F.2, Am-A

To transport, as a common carrier, by motor vehicle, Persons upon call or demand in the Borough of New Hope, Bucks County, and within an airline distance of 15 statute miles of the limits of said Borough.

A-00121368, F.3, Am-A (C)

To transport, as a common carrier, by motor vehicle, persons, upon call or demand, in the borough of Quakertown, in that portion of Richland Township north of the borough of Quakertown and in that portion of Richland Township south of the borough of Quakertown to Tollgate Road/Paletown Road, all in the county of Bucks. Subject to the following conditions:

That no right, power or privilege is granted to render service in the boroughs of Sellersville and Perkasie, all in Bucks County; and that no right, power or privilege is granted to render service in the boroughs of Hatfield, Lansdale, Souderton, Telford and North Wales, and the townships of Montgomery, Hatfield, Upper Gwynedd, Lower Gwynedd, Towamencin, Whitpain, Worcester, Lower Salford and Franconia, all in the County of Montgomery,

To Transport, as a common carrier, persons upon Call or Demand to the portion of Richland Township south of Tollgate Road/Paletown Road, the townships (including all boroughs therein not otherwise specified) of Milford, Springfield, Haycock, East Rockhill, and West Rockhill, and the boroughs of Sellersville, Perkasie and Telford, all in Bucks County; and the townships (including all boroughs therein not otherwise specified) of Upper Hanover, Marlborough, Salford, Upper Salford, Upper Frederick, and the boroughs of Harleysville, Telford, and Souderton, all in Montgomery County, to points in Pennsylvania and return.
