Perigee Energy, LLC ("Perigee") hereby serves notice to the Pennsylvania Public Utility Commission ("PAPUC") of its desire to abandon its license to supply electricity in the Commonwealth of Pennsylvania. Perigee does not now, nor has it ever, have customers in the Commonwealth of Pennsylvania under this license. In connection with the abandonment of its license, Perigee requests the release of the bond securing this license, Bond No. 012017106, as soon as practicable. The only utility that Perigee has commenced EDI testing with is PECO, though again, no customers were served in that territory, nor any other in the Commonwealth of Pennsylvania.

Also included here is a Certificate of Service for the four (4) required statutory agencies and PECO.


