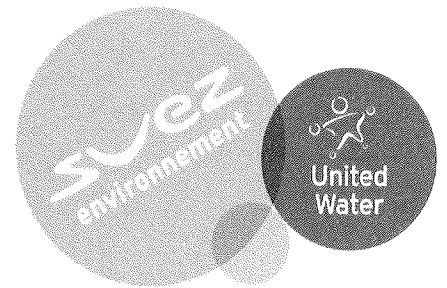

Supplement No. 50 to Tariff Water - Pa. PUC No. 3 and Supporting Information**

Dear Secretary Chiavetta:

Enclosed please find the original and one (1) copy of United Water Bethel Inc.'s ("UW Bethel") Supplement No. 50 to Tariff - Water — Pa. P.U.C. No. 3 ("Supplement No. 50"). Supplement No. 50 contains an issued date of March 24, 2015 and an effective date of May 23, 2015 (which is 60 days from the date of filing). In Supplement No. 50, UW Bethel proposes to change the billing period of its customers from quarterly to monthly.

UW Bethel has approximately 2,400 customers which are currently all billed at the same time in January, April, July and October. Taking into account the Company's billing schedule and the Commission's meeting dates, the Company plans, absent suspension of the effective date of Supplement No. 50, to begin billing its customers on a monthly rather than a quarterly basis in August, 2015. The last quarterly bill would be sent on or about July 24, 2015.


