

Dear Secretary Chiavetta:

On March 17, 2015, the Recommended Decision of Administrative Law Judge Dennis J. Buckley and Administrative Law Judge Katrina L. Dunderdale (“ALJs”) was issued in the above-captioned rate proceeding. In their Recommended Decision, the ALJs recommended the approval without modification of the Joint Petition for Partial Settlement of Rate Investigation (“Joint Petition”) filed on February 3, 2015, and, with respect to the sole issue reserved for litigation, recommended the adoption of Metropolitan Edison Company’s (“Met-Ed”) proposed Light Emitting Diode (“LED”) Street Lighting Service offering.
