Please find enclosed an original and one copy of Philadelphia Energy Solutions Refining and Marketing, LLC ("PESRM") Act 127 Registration submission for 2014, along with the required \$250 check. This is a new registration for facilities that PESRM purchased in September 2012 from Sunoco, Inc. and will require assignment of a new docket number.

While PESRM has been in compliance with the requirements of the U.S. Department of Transportation, Pipeline Hazardous Materials Safety Administration (PHMSA) since it purchased the facilities, we became aware recently of the Pennsylvania registration requirements under Act 127.
