ORDER STAYING PROCEEDING

By letter dated March 11, 2005, DIECA Communications, Inc. t/a Covad Communications Company (Covad) and Verizon Pennsylvania, Inc. and Verizon North, Inc. (Verizon) (collectively, the parties) informed me that they have reached agreement on issues 4, 8, 13, 27, 30, 32, 33, 34, 35 and 38 and that these issues do not need to be addressed in this proceeding.

They requested that issues 19, 24, 25, 35, 36, 37, 42, 32, 44 and 47 be deferred pending completion of the consolidated arbitration proceeding at Docket P-000422092, and that I issue a decision with respect to the remaining issues 1, 2/9, 5, 7, 10, 12, 22, 23, 52 and 53. This request was granted by Order Regarding Bifurcation and Supplemental Briefs dated March 11, 2005.

Given the substantial amount of time that has elapsed since briefs were filed, in that Order I also directed the parties to file supplemental main and reply briefs limited to issues 1, 2/9, 5, 7, 10, 12, 22, 23, 52 and 53.


Upon further consideration, it appeared that the better approach to handling the bifurcated issues is to defer consideration of all issues pending completion of the consolidated arbitration proceeding. Both Covad and Verizon have agreed.

THEREFORE,

IT IS ORDERED:

1. That this proceeding is stayed pending completion of the consolidated arbitration proceeding at Docket P-000422092.
