MOTION FOR CONTINUANCE OF HEARING DATE

PECO Energy Company ("PECO Energy"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. An in person hearing for this matter is currently scheduled to take place on a Call of the Docket, Thursday, April 16, 2015 at 9:00 a.m.
2. The Complainant's formal complaint requests a payment agreement and disputes PECO's threat of termination of service.
3. During a pre-hearing resolution discussion, the Complainant indicated that she had some issues with high bills and is disputing high bills at her property.
4. In order to defend its case, PECO Energy must present the testimony of High Bill Foreman, Thomas Lerro and present a high bill field report of an investigation that took place at the Complainant's property.
5. The company must also defend the payment agreement request and termination dispute with the testimony of a Regulatory Assessor.
6. Because this matter requires the testimony of two witnesses and a high bill defense, this matter is not appropriate for a Call of the Docket hearing.
7. Accordingly, PECO Energy is requesting that this matter be scheduled for a hearing date, which is not a Call of the Docket.
