Kaplan against Comcast ("Complaint"), which was served on March 16, 2015, has been satisfied, and in support thereof states as follows:


1. The Complaint filed against Comcast by Lillian C. Stark ("Ms. Stark") and Mitchell A. Kaplan ("Mr. Kaplan") with the Pennsylvania Public Utility Commission ("PUC"), was served on March 16, 2015, and alleged an incorrect billing amount.
2. Since the filing of the Complaint, representatives of Comcast have worked with Complainants to resolve the concerns raised in the Complaint.
3. Comcast has since resolved all of the concerns raised in the Complaint.
4. On March 23, 2015, Jeremy Cassell, a Customer Relations representative for Comcast, spoke with Mr. Kaplan, who acknowledged that both he and his wife, Ms. Stark, are satisfied with the resolution that was reached and that this Complaint is satisfied.


