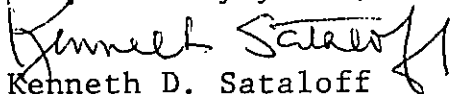

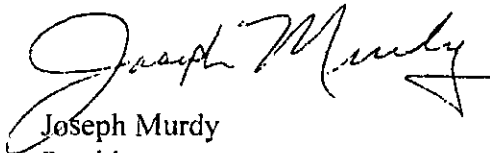

NOTE 3 - When distance from original point of origin to final destination is:

- (a) 20 miles or less - flat charge shall be one hour at the rates applicable.
- (b) Over 20 miles but less than 30 - flat charge shall be one and one-half hours at the applicable rates.
- (c) Over 30 (to 40 miles inclusive) - flat charge shall be two hours at the applicable rates.
