**RIGHT-OF-WAY AGREEMENT FOR TREE WORK**  
**(Corporation)**

KNOWN ALL MEN BY THESE PRESENTS, That Pine Grove Township, a municipal corporation of Pennsylvania hereinafter called "GRANTOR", intending to be legally bound, does hereby for itself, its successors, assigns grant unto **PPL Electric Utilities Corporation**, hereinafter called "COMPANY" its successors, assigns and lessees, the right, privilege and authority to cut down ANY AND ALL trees within TWENTY-FIVE (25') feet each side of centerline of the electric line and the right to trim ANY AND ALL trees within TWENTY-FIVE (25') feet each side of centerline of the electric line and to remove brush along said lines which in the judgment of the said Company menace the said lines; located on the property which the undersigned owns or has any interest located along OAK GROVE ROAD, TOWNSHIP of PINE GROVE, County of SCHUYLKILL, Commonwealth of Pennsylvania.

A copy of this agreement and an acceptance hereof by PPL shall be filed by PPL with the Pennsylvania Public Utility Commission, and this agreement shall thereafter become effective in accordance with the provisions of the Public Utility Law.


