### ORDER STAYING PROCEEDING

:

THEREFORE,

IT IS ORDERED:



1. That the motion to strike, dismiss or stay the petition of Core Communications, Inc. in this proceeding, filed by Alltel Pennsylvania, Inc. on April 24, 2006, is granted to the extent set forth in this order.

2. That the motion for admission pro hac vice filed on May 8, 2006 by Holly Rachel Smith, Esquire, on behalf of Kimberly K. Bennett, Esquire and Cesar Caballero, Esquire is granted. Ms. Bennett and Mr. Caballero are admitted pro hac vice to represent Alltel Pennsylvania, Inc. in this proceeding. Ms. Smith remains counsel of record for Alltel Pennsylvania, Inc.

3 That the motion to stay the petition of Core Communications, Inc. in this proceeding, filed by the Rural Telephone Company Coalition, Pennsylvania Telephone Association and the Frontier Companies on April 28, 2006, is denied as moot. 4. That each party shall be limited to the entries on the service list as set forth in this order. Any changes should be communicated to me, via e-mail (dsalapa@state.pa.us) as soon as possible. 6. That within thirty-five days of the entry of the final order in the application referenced in paragraph five of this order, Core Communications, Inc. will notify Alltel Pennsylvania, Inc. and me in writing of its intended course of action. The parties reserve all appellate rights and in the event an appeal is filed, Core Communications, Inc. and Alltel Pennsylvania, Inc. reserve the right to seek a further stay.

7. That Core Communications, Inc. and Alltel Pennsylvania, Inc. waive the nine-month deadline for rendering an arbitration decision set forth in 47 U.S.C. §252 and they waive their right to petition the Federal Communications Commission under 47 U.S.C. §252(e)(5) for failure of the Pennsylvania Public Utility Commission to act on the arbitration within the statutory deadline.
