This, however, does not constitute a determination that the tariff revisions are just, lawful and reasonable, but only that suspension or further investigation does not appear to be warranted at this time and is without prejudice to any formal complaints timely filed against said tariff revisions.

Please be advised that 66 Pa. C.S. § 3018(b)(2) gives interexchange carriers (IXCs) three options regarding intrastate tariffs: (1) operate as a detariffed IXC¹ by submitting a letter to the Secretary's Bureau canceling their respective tariff on file with the Commission and withdrawing any pending tariff supplements, (2) maintain a price list in lieu of a tariff by submitting a letter to the Secretary's Bureau (updates to price lists will be processed in the same manner as tariff revisions), or (3) continue to maintain a tariff with the Commission following the current process.

Please note that an IXC that is not detariffed is required to maintain its most current tariffs on its website with a link to the Commission's website. However, staff was unable to access your Company's current online tariffs. Specifically, the online version of Tariff No.5 has not been updated to reflect the pending revisions contained in Supplement No. 10. Therefore, within 10 days of the date of this letter, the Company is directed to update its online tariffs and provide confirmation to J. Elaine McDonald at jmcdonald@state.pa.us.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code § 5.44, file a petition with the Commission within 20 days of the date of this letter. Questions in this matter may be directed to Eric Jeschke, Bureau of Fixed Utility Services at (717) 783-3850.
