Dear Sir or Madam:

I am writing to provide formal notice that effective September 19, 2000, the name for PurePacket Communications of the Northeast, Inc., a Delaware corporation, has been changed to BroadRiver Communications of the Northeast Corporation ("The Company"). On August 17, 2000, the Pennsylvania Public Utility Commission issued an Order in Docket No. A-310937 and A-310937F0002 granting approval to PurePacket to provide telecommunications services as a Reseller of Interexchange Toll Services and as a Competitive Local Exchange Carrier (CLEC) in the State of Pennsylvania.

Due to trademark licensing issues, the Company recently implemented a name change across all of the PurePacket Communications corporate entities. This amendment represents a change in name only and not a change in corporate ownership or status. In addition, the Company does not currently serve any customers within the State of Pennsylvania, thereby avoiding any potential customer confusion in the marketplace.

I have included copies of the Company's: i) Application for Amended Certificate of Authority Foreign Corporation which was filed with the Pennsylvania Secretary of State on 10/11/00, and ii) documentation from the State of Delaware referencing the corporate name change on 9/19/00. Accordingly, please amend the certificates of authority to provide resold interexchange toll services and Competitive Local Exchange service previously issued to PurePacket Communications of the Northeast, Inc., to reference the new corporate name of BroadRiver Communications of the Northeast Corporation.


