Ramsey's Moving Systems, LLC is seeking an increase in hourly rates, selective increase in packing container rates and increase in the replacement cost protection coverage for the transportation of household goods in use.

Also attached is an affidavit stating that its 2014 Pa. Gross Revenues were less than \$500,000 and its operating ratio was not less than 93%. The carrier's 2014 Assessment Report reflects household goods in use revenues amounted to \$594,829, however what what not accounted for is the inner office and residential service which is "excempt" revenues.

The proposed loose-leaf revisions have been filed on sixty (60) day's notice to be effective June 15, 2015 unless suspended otherwise.

- NOTE 2 Item 325 in Tariff Freight PA. P.U.C. No. 50 will not be offered.
- NOTE 3 Where storage-in-transit shipment is not unloaded at carrier's warehouse, and shipment remains on carrier's vehicle, an overnight S.I.T. flat charge of ◆\$150.00 per vehicle will be assessed. Waiting charge will be assessed by carrier on the basis of a vehicle, driver and one helper at the applicable hourly rates shown above from 8 A.M. following overnight S.I.T. flat charge <u>until</u> carrier's employees and equipment arrive at customer's location for unloading. Thereafter, carrier's hourly rates above will be assessed based on the equipment and labor furnished by carrier from the commencement of unloading until completion of unloading and dismissal of equipment and labor by shipper.
- ▲NOTE 4 When pianos, large tv's and safes are a part of the shipment, the following flat rate charges will be assessed in addition to the hourly rates. Spinet \$75; High Back Upright- \$150; Baby Grand \$150; Grand Piano \$300; Large Flat Screen TV's over 64" \$150; Safes \$75 (2 hour minimum) per man per hour; after 2 hour minimum \$37.50 per man per half hour.
- ▲NOTE 5 A flat \$25.00 per flight charge will be assessed for heavy articles excluding the first flight shall consists of a total of at least 8 steps. Additional flight shall be defined as the number of complete floors, above or below the first flight.
- NOTE AA (Applicable only to Delaware County)

A flat charge based on one hour at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is 10 miles or less.

A flat charge based on one and one half hours at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is more than 10 miles but not exceeding 20 miles.

A flat charge based on two hours at the applicable transportation rates shown in Columns 2 or 3 when distance from original point of origin to final destination is more than 20 miles but not to exceed 40 miles.

NOTE BB - (Applicable only to Chester, Montgomery and Philadelphia Counties)

(1) Origin and destination is within 10 miles or carrier's terminal - 1 hour at the applicable rates.

- (2) Origin or destination is between 11 and 20 miles of carrier's terminal 1.5 hours at the applicable rates.
- (3) Origin or destination is between 21 and 30 miles of carrier's terminal 2 hours at the applicable rates.

(4) Origin or destination is between 31 and 40 miles of carrier's terminal - 3 hours at the applicable rates.
