CREDIT OPINION

Rating Rationale

NRG's Ba3 corporate family rating primarily reflects its position as the largest independent power producer in the U.S. in terms of generating capacity. The rating also incorporates the company's significant debt leverage and the current weak market conditions for U.S. merchant companies. These market conditions have been heavily driven by low natural gas prices, for which we do not foresee a meaningful recovery in the next few years due to the glut of natural gas reserves created by continued shale gas development. Surplus generating capacity has been an important contributing factor for the current market conditions as well. However, it appears that the US merchant power markets have bottomed out, with some markets showing potential for improvements. As the incumbent, NRGs retail operation in Texas also provides sizeable, stable cash flow. NRG's corporate family rating of Ba3 is rated three notches higher than the corporate family rating of B3 for its GenOn subsidiaries, reflecting NRG's limited support to GenOn and its subsidiaries.

Rating Outlook

The stable outlook reflects NRGs solid cash flow generation capabilities in the midst of a downturn for the sector. NRG has been active with shareholder friendly initiatives such as raising dividends and forming NRG Yield Co. These initiatives can have negative rating implications because of their effect on leverage; however, we would incorporate any mitigating factors and consider the facts and circumstances at the time to determine if a rating action is necessary.

What Could Change the Rating - Up

A fundamental improvement in the merchant power market or a moderation in NRGs current debt leverage to above 12% CFO-pre-working-capital/debt on a sustained basis could result in upward rating pressure.

What Could Change the Rating - Down

We may take a negative rating action should cash flow leverage deteriorate significantly to 7% CFO-pre-working-capital to debt without incorporating the effects of GenOn's financial position.



NRG Home is dedicated to completing the necessary actions and commitments required to provide reliable retail natural gas service to Pennsylvania customers, and it brings together an experienced management team and a highly qualified technical staff to ensure the delivery of best in class value, service, and support to consumers in the Commonwealth of Pennsylvania.

The company has the necessary technical and managerial resources to enter into and comply with contracts to purchase capacity and energy, or ancillary services, as may be required by another independent organization to provide adequate natural gas to all NRG Home customers.

The management team and colleagues at NRG Home have first-hand knowledge of customer operations and utility business management and will draw on its technical and managerial expertise, in combination with its relationships with experts in the Pennsylvania market, to successfully develop and implement the infrastructure, systems, and processes to provide service to Pennsylvania natural gas customers.





8.c. DOOR TO DOOR SALES: Will the Applicant be implementing door to door sales activities?

If yes, describe the Applicant's verification procedures.

Tablet Enrollment

NRG Home employs tablets to enroll customers at the customer's home or at public events. The tables use GPS to verify all sales activity. NRG Home is able to locate the sales agent in real-time and remotely shut off any tablet in the event of any questionable activity. NRG Home can also locate any sales made by the agent and verify the route the agent has taken at any point throughout the day. This functionality also allows for reporting related to the frequency of sales, the timing between sales, and verification of distance of the sale vs. the location of the customer's home address. All reporting has related alerts that are sent out depending on situation.

TPV Process

NRG Home utilizes a third party verification process when completing any door-to-door enrollment so as to have a recorded verification from the customer, indicating they agree to all of the relevant information completed on the tablet and discussed with the sales agent. NRG Home confirms customer's name, address and that the person speaking is authorized to act on behalf of the account holder (if applicable in the market in question). NRG also confirms the customer's understanding of authorizing a switch of suppliers and that their natural gas delivery, meter reading and billing will continue to be provided by the utility. NRG Home makes it clear the new suppliers' supply charges will replace the current supply charges within their utility's name. Finally, NRG Home confirms that the customer agrees to allow NRG Home to take the necessary steps to become the customer's natural gas supplier.

8. d. OVERSIGHT OF MARKETING: Explain all methods Applicant will use to ensure all marketing is performed in an ethical manner, for both employees and subcontractors.

Sales/Marketing Materials: NRG Home employs a sales and marketing compliance review process that ensures that all customer-facing material is reviewed for regulatory and legal compliance prior to being deployed in the field. Our Creative Review Process (CRP) utilizes a Share Point site that serves as the central clearinghouse. All customer and external facing collateral material is submitted for review, including: all marketing message maps/documents; solicitation materials (direct mail, email, phone/door-to-door/face to face events/campaigns, etc.); marketing collateral; advertising (web, TV, radio, bill boards, etc.); agent training materials; agent scripts (sales, call center reps, TPV, etc.); welcome kits/letters; renewal letters; customer notices/communications; website content; press releases; etc. All NRG Home employees involved in the production of customer facing materials have access to the CRP system and submit their materials for review and approval.

NRG Home Call Center Reps: NRG customer service agent training content covers customer choice, product details, and market/sales regulations within 80 hours of instructor led training, and 40 hours of on the job training. Upon completion of training, all agents are required to sign a Quality Assurance Agreement indicating that they understand specific market/sales regulations and that they will follow applicable guidelines. All call center agents are audited each month to ensure quality standards and compliance with regulations, and there are penalties for non-compliance.

Face-to-Face Sales: NRG Home contracts with Vendors that provide the sales agents to conduct our face-to-face sales (both at the doorstep and in public venues). NRG Home ensures that these vendors and their agents are fully trained, knowledgeable about our products and services and the consumer protection rules, and most importantly, delivering quality sales and happy customers. To achieve those goals, NRG Home has established a comprehensive Quality Assurance Program that consists of five key components, including:

- Full-time Quality Assurance Staff: We employ full-time in-house staff located at our
 corporate office and in the field offices; their full time jobs are to train, monitor,
 evaluate, audit all face-to-face sales activities and proactively address concerns/issues in
 an effort to avoid/minimize complaints. They also ensure agents have the materials/
 resources they need. Market managers are assigned to each state to manage all face-toface product offers and campaigns and interact with agents/vendors on an ongoing
 basis.
- Robust training and certification process: All agent training is conducted either by our own QA analysts or a vendor trainer that has been certified by our QA analyst. NRG Home provides all training materials. Training is ongoing depending on the season in the summer typically weekly.

- Our onboarding process includes: required background checks, certification through training/testing agents must score at least an 85% and the agent exam, agents must agree to sign/adhere to our code of ethics and consumer protection rules; we must obtain a digital or hard copy of all signed documents before an agent is certified to sell.
- Agents trained on the code of ethics/consumer protection rules, uniform requirements, sales techniques, our products, and the proper procedures for completing the sales transaction and TPV. Training is typically two days includes classroom/field training, followed by a week of shadowing.
- Thorough auditing process: includes performance measures and scoring metrics for
 individual agents. The goal is to identify trends/discrepancies that raise flags and help us
 to identify and address problems with our agents. Process includes face-to-face audits
 as well as audits of enrollment forms, TPV calls, and outbound surveying of customers.
- Detailed performance measures for agents: allows us to objectively rate and track
 agent performance; Agents rated on 24 areas of performance measured during face-toface audits range from visibility of ID badge, uniform/appearance, behavior, proper
 materials used, current disclosure statement, proper explanation of competition, utility
 and retailer roles; accuracy of product description, sales technique, accuracy of
 explanation of key terms, provision of rescission notice and copies of materials, proper
 completion of enrollment forms/tablet process, proper transfer to TPV.
- Robust complaint handling/discipline process: process established to address
 concerns/issues with agents; NRG Home monitors and tracks all complaints and
 categorizes them according to severity, and to specifically identify major/mid-level
 complaints (disputed enrollments, misrepresentation, behavior, PUC complaints, etc.);
 established guidelines dictate course of disciplinary action.

A. Important Information

Our service will continue until either of us cancels the contract.

<u>Basic Service Price and Limits on Price Variability for Your Electricity:</u>

For Your Natural Gas: Your introductory natural gas supply price will be \$X.XXXXX per [gas UOM] for your first [XX] full billing cycles. After your first [XX] billing cycles you will be charged a variable supply price. We will determine the

variable supply price in our discretion based on many different factors, which may include competitive prices, industry charges we are responsible for, applicable state and local taxes, profit margins, or other business conditions. For your reference, our natural gas supply prices include natural gas supply and transportation charges and estimated total state taxes, but they do not include any state sales tax, county tax, utility distribution charges or other utility fee or charge. Your variable supply price may change monthly, but, no matter what, we will not increase your variable price in any given month by more than 30% from the prior month's supply price. Our current and historical prices are not an indicator of our future prices and we do not

guarantee any savings. Our prices may be higher than your utility's supply rate

Billing: Your local utility is responsible for sending you a bill that includes the charges for our service and charges for the utility's service. You also agree to review your bills in a timely manner, and if there are any inaccuracies with the portion of the bill for our services, you agree to notify us within ninety days after the date of the bill. If we do not hear from you, you are agreeing that the billed amounts are correct and you are waiving any right to dispute the billed amounts to the extent permitted by law.

Right to Rescind: You have the "Right to Rescind" this contract for three business days, which means you can cancel your request to switch your natural gas service and never start service with us. You will receive a Welcome Confirmation from us, which will include this contract, and you will have until midnight of the third business day after receipt of the Welcome Confirmation to rescind this contract by contacting us at the telephone number or email address listed below. This contract is not binding until your "Right to Rescind" period has ended with no action on your part to rescind the contract.

Contract Renewal and Expiration Provisions or Change in Terms: This contract automatically renews at the end of each month and will continue to renew on a month to month basis until either of us cancels the contract. You may cancel without a cancellation fee. If you have a fixed term contract approaching the expiration date, or whenever we propose to change the terms of service in any type of contract, you will receive two separate written notifications that precede either the expiration date or the effective date of the proposed changes. These notifications will explain your options going forward.

<u>Special Terms and Conditions:</u> Rewards Program. Please refer to your Welcome Confirmation for the terms regarding your rewards program. If you cancel this contract, you may forfeit some or all of the rewards described in your Welcome Confirmation.

Applicable Fees: None. If you are currently in a contract with another natural gas supplier, the request to switch you to our service will automatically cancel your service with the other natural gas supplier. You are responsible for any penalties the other natural gas supplier may charge.

Your Right to Cancel: You may cancel this contract without having to pay a cancellation fee by calling us at our contact information listed below. We will request that the utility cancel your service with us, but the utility controls the effective date of your cancellation.

It may take 1 or 2 billing cycles before the cancellation is finalized, depending on your utility's timeframe for processing our cancellation request.

If you do cancel this contract, you may forfeit some of the rewards that we describe in your Welcome Confirmation, and you will be responsible for unpaid balances as of the cancellation date.

Our Right to Cancel and Cancellation Provisions: We have the right to cancel this contract for any reason as long as we give you thirty days' written notice, but if we are canceling the contract due to your conduct or your breach of this contract, you will have an opportunity to fix this condition within the thirty days. Your utility will control the effective date of our cancellation. If your utility terminates your service, this contract will be automatically cancelled.

It may take 1 or 2 billing cycles before the cancellation is finalized, depending on your utility's timeframe for processing our cancellation request.

If your utility terminates your natural gas service, this contract will be automatically cancelled.

Your Authorization to Release Your Information: This contract provides authorization for your utility to release all information regarding your natural gas account to us and for us to contact you about our other products and services or share information about your account with any designated rewards partner or with any third-party vendor we use to provide services and rewards to you. We reserve the right to share information with our affiliates, to the extent permitted by law. If you do not wish for us to share information about your account, you may cancel this contract by calling us at our contact information listed below.

Electronic Communication: If you provide us with your Email address, you are consenting to this contract and other forms of communication being provided to you in electronic form and you must provide us with any update to your valid Email address should it change. You are required to notify us of any change in Email address and/or any withdrawal of consent for the electronic transmission of contracts or other customer information. If you enroll electronically, please note that our website and application is best viewed in Internet Explorer 8.0 or higher.

<u>Taxes</u>: Any applicable tax charges are included on the one bill you will receive from your utility. If you are exempt from any taxes, you are responsible for requesting an exemption by filing all required documentation with us and/or your utility.

<u>Background:</u> We are licensed by the Pennsylvania Public Utility Commission (PUC) to offer and supply natural gas generation and related services in Pennsylvania. Our license number is TBD. We set the generation prices and charges that you pay. The Public Utility Commission regulates distribution prices and services. The Federal Energy Regulatory Commission regulates transmission prices and services.

Definitions:

Commodity charge or natural gas supply charge—Basic service charges for natural gas supply services to retail customers, excluding charges for natural gas distribution services.

Distribution Charge - Cost for delivering natural gas from your natural gas distribution company (your utility) to your home or business. These charges continue to be regulated by the PUC.

Contract Details: Our full, legal name is Reliant Energy Northeast LCC d/b/a NRG Home and NRG Retail Solutions, but we have used "NRG Home", "we", "us", or "our" to refer to ourselves for the purposes of this contract. We use "you" or "your" to refer to you, the customer. This contract is for the sale and purchase of all of your natural gas for the residential account(s) listed in your Welcome Confirmation (letter or email). By entering into this contract, you are authorizing us to take the steps necessary to switch your natural gas supply service to us, and you agree to appoint us as your agent to acquire the necessary information to meet your natural gas needs as required by your "utility", which we use to refer to your local distribution company. Your utility is responsible for the delivery of natural gas to you and we are not. This Terms of Service is your entire contract with us and replaces any prior oral or written statements or representations.

<u>Contract Changes</u>: Whenever we propose to change the terms of service in any type of contract, you will receive two separate written notifications that precede the effective date of the proposed changes. These notifications will explain your options going forward. We will not change or alter the waiver of jury trial provision under any circumstances, and any changes to this contract must be made in writing.

<u>Customer Complaints and Dispute Procedures</u>: If you have questions about our prices or our service, you should call us at the contact information listed below. If you are not satisfied with the response from our Customer Care representative, you may ask that your questions be referred to one of our supervisors, who will respond promptly. If you remain unsatisfied with our attempts to resolve the issue, you may seek assistance from the PUC or request information from the PUC regarding your consumer protection rights. The PUC's contact information is listed below.

You may not assign this contract.

No Reliance: You acknowledge that (1) you are not relying on any advice, statements, recommendations or representations of ours other than the written representations in this contract; (2) that you consulted with your own advisors to the extent you deemed necessary; and (3) that you understand the risks of entering into this contract, including the risk that our prices may be higher than your utility's rates. You acknowledge that you are capable and willing to assume those risks (whether financial, economic or otherwise) and that you have made your own decision to enter into this contract.

Force Majeure: We will use commercially reasonable efforts to provide natural gas supply to you pursuant to this contract, but we do not guarantee a continuous supply of electricity. Certain Force Majeure events outside of our control may cause interruptions in service. If a Force Majeure event prevents us from performing any of our obligations in any way, our performance shall be excused for the duration of such event, and we will not be liable for damages associated

with any delay or failure to perform as a result. "Force Majeure" includes, without limitation, acts outside of our control, sabotage, riots or civil disturbances, acts of God, acts of the public enemy, acts of vandalism, terrorist acts, natural disasters, explosions, fires, or similarly cataclysmic occurrence, failure, shortage or unavailability of generating units or transmission facilities, nonperformance by your local utility, or any change in law or any other action by a governmental authority that materially impairs our ability to perform our obligations under this contract. We will give you reasonably prompt notice of any Force Majeure occurrence.

Severability: Each provision of this contract is made subject to the maximum extent permitted by law. If any are held to be unenforceable or invalid by any arbitrator or court of competent jurisdiction, we will negotiate an equitable adjustment to or an amendment of the affected provisions with you with a view toward effecting the purpose of this contract. In this case, the validity and enforceability of the remaining provisions shall not be affected.

LIMITATIONS ON WARRANTY AND DAMAGES: THE NATURAL GAS PROVIDED UNDER THIS CONTRACT WILL, MEET THE QUALITY STANDARDS OF YOUR UTILITY. YOU UNDERSTAND AND AGREE THAT THERE ARE NO OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, ASSOCIATED WITH THE SERVICE PROVIDED BY US. WE HAVE NO

LIABILITY FOR SERVICE INTERRUPTIONS NOR ANY ASSOCIATED LOSS OR DAMAGE RESULTING FROM SUCH INTERRUPTIONS. TO THE MAXIMUM EXTENT PERMITTED BY PENNSYLVANIA LAW, LIABILITIES NOT EXCUSED BY REASON OF FORCE MAJEURE OR OTHERWISE SHALL BE LIMITED TO DIRECT ACTUAL DAMAGES. WE WILL BEAR NO LIABILITY TO YOU OR ANY THIRD PARTY FOR CONSEQUENTIAL, PUNITIVE, INCIDENTAL, SPECIAL, EXEMPLARY OR OTHER INDIRECT DAMAGES OR LOST PROFITS. BY ENTERING INTO THIS CONTRACT, YOU ARE GIVING UP YOUR RIGHTS TO SEEK REMEDIES IN COURT, OTHER THAN IN SMALL CLAIMS COURT, AND THE RIGHT TO A JURY TRIAL. THE ABILITY TO CONDUCT DISCOVERY IN ARBITRATION IS LIMITED AND THE ARBITRATOR'S DECISION IS SUBJECT TO VERY LIMITED REVIEW BY COURTS. ARBITRATORS CAN AWARD THE SAME DAMAGES AND RELIEF THAT A COURT CAN AWARD. THE AAA SHALL HAVE THE POWER TO RULE ON ANY CHALLENGE TO ITS OWN JURISDICTION OR TO THE VALIDITY OR ENFORCEABILITY OF ANY PORTION OF THIS ARBITRATION PROVISION. THE PARTIES AGREE THAT ALL CLAIMS INCLUDING STATUTORY, STATE OR FEDERAL CLAIMS, MAY BE MADE SOLELY ON AN INDIVIDUAL BASIS, AND THAT THIS CONTRACT DOES NOT PERMIT CLASS ACTIONS, EITHER IN ARBITRATION OR THROUGH A COURT PROCEEDING. AAA MAY NOT CONSOLIDATE MORE THAN ONE PERSON'S CLAIMS, AND MAY NOT OTHERWISE PRESIDE OVER ANY FORM OF A REPRESENTATIVE OR CLASS PROCEEDING. IN THE EVENT THE PROHIBITION ON CLASS ARBITRATION IS DEEMED INVALID OR UNENFORCEABLE, THEN THE ENTIRETY OF THIS ARBITRATION PROVISION SHALL BE NULL AND VOID. JUDGMENT ON THE ARBITRATOR'S AWARD CAN BE ENTERED IN ANY COURT HAVING JURISDICTION. This contract is made and shall be construed in accordance with the laws of Pennsylvania. There are no third party beneficiaries to this contract. This contract is binding upon us and you, as well as any successors or legal assigns. Failure to exercise any right we

have under this contract should not be considered as a waiver of the right to exercise any such right at a later date. The headings and Summary of Important Information chart in this contract are for reference only and do not affect the interpretation of this contract.
