Pursuant to 52 Pa. Code § 5.94, HIKO Energy, LLC (HIKO) hereby withdraws its Petition for Interlocutory Review filed on April 10, 2015 and request that the schedule for the filing of briefs in support of or in objection to this Petition be suspended.
