Dear Secretary Chiavetta:

Pursuant to an e-mail request received from the Secretary's Bureau on April 27, 2015, we have enclosed for filing with the Pennsylvania Public Utility Commission ("PUC" or "Commission") a Verification to the Petition for Reconsideration of the PP&L Industrial Customer Alliance ("PPLICA") which was filed on April 24, 2015, in the above-referenced proceeding.

By way of clarification, we did not initially provide a Verification with the April 24, 2015 filing because Section 1.36(a) of the Commission's Regulations requires a Verification for Petitions "containing an averment of fact not appearing of record in the action." 52 Pa. Code § 1.36(a). The Petition for Reconsideration filed by PPLICA on April 24, 2015 addressed exclusively legal matters and cited to record facts and legal authority (such as legislative history). Accordingly, we did not deem a Verification necessary pursuant to Section 1.36.

However, out of an abundance of caution, we have enclosed the attached Verification consistent with the April 27 request.
