Dear Mr. McNulty:

AT&T Broadband Phone of Pennsylvania, LLC ("AT&T Broadband Phone of Pennsylvania"), by its attorneys, hereby respectfully notifies the Pennsylvania Public Utility Commission (the "Commission") that its name will be changed to Comcast Phone of Pennsylvania, LLC, d/b/a Comcast Digital Phone.¹ AT&T Broadband Phone of Pennsylvania currently is authorized by the Commission to provide facilities-based and resold interexchange service, facilities-based local exchange service and competitive access service to customers within the State of Pennsylvania.² The name change described herein is expected to be implemented on February 14, 2003.

This name change is related to the merger of AT&T Broadband Corp., including its telephony operations, with Comcast Corporation, which was approved by the Commission on

July 19, 2002.³ By letter dated November 26, 2002, AT&T Broadband Phone of Pennsylvania and Comcast Business Communications, Inc. notified the Commission of the consummation of the merger transaction and the related name change of certain of the holding companies. This filing relates to the name change of the entity providing telecommunications service within the State of Pennsylvania. AT&T Broadband Phone of Pennsylvania is a wholly owned subsidiary of Comcast Phone, LLC (formerly known as AT&T Broadband Phone, LLC), which in turn is a wholly owned subsidiary of Comcast Cable Communications Holdings, Inc. (formerly known as AT&T Broadband Corp.). Comcast Corporation (formerly known as AT&T Comcast Corporation) is the ultimate parent of the foregoing entities. The name change will not result in a change in the carrier providing telecommunications services to customers in Pennsylvania, or in the telecommunications services, rates, terms and conditions of service that those customers currently enjoy. There also will be no change in the current contacts for Commission and customer inquiries. Accordingly, the name change described herein will have no adverse impact upon the current customers of AT&T Broadband Phone of Pennsylvania. Some confusion already has occurred with regard to the forwarding of customer complaints and inquiries to AT&T Corp., rather than to AT&T Broadband Phone of Pennsylvania, and it is expected that the proposed name change will alleviate this problem.

To avoid any customer confusion or inconvenience, AT&T Broadband Phone of Pennsylvania will provide written notification of the name change described herein to all current customers of AT&T Broadband Phone of Pennsylvania by means of a bill notification or insert. At a minimum, the appropriate notification will be included with each customer bill not less than thirty (30) days prior to the proposed name change. The text of the notification to be provided to the current customers of AT&T Broadband Phone of Pennsylvania is attached hereto as *Exhibit B*.


The existing tariff title page and list of changes page for AT&T Broadband Phone of Pennsylvania's Competitive Local Service Tariff No.1, Facilities Based Interexchange Service Tariff No. 2, Interexchange Reseller Service Tariff No. 3 and Switched Access Services Tariff No. 4 have been revised to reflect the name change described herein. The tariff title page and list of changes page submitted herewith bears an effective date of February 14, 2003, which is the date on which AT&T Broadband Phone of Pennsylvania expects to initiate telecommunications service under the new name, Comcast Phone of Pennsylvania, LLC. A copy of the aforementioned tariff pages are attached hereto as *Exhibit C*. It is respectfully requested that the existing tariff of AT&T Broadband Phone of Pennsylvania be cancelled on the effective date of the tariff filed herewith.




