
Zody's Moving & Storage, Inc. is seeking an increase in its hourly rates transporting household goods in use for distances of forty (40) miles and less.



▲NOTE 2 - Moving service requiring more than 4 men, a charge of \$28.00 per man per hour.

NOTE AA - When distance from original point of origin to final destination is:  
 (a) Fifteen (15) miles or less - flat charge shall be one-half hour at the applicable rates.  
 (b) Over 15 miles but less than 30 - flat charge shall be one hour at the applicable rates.  
 (c) Thirty (30) miles (to 40 miles inclusive) - flat charge shall be one and one-half hours at the applicable rates.
