
Petition to Intervene of the United States General Services Administration and Notice of Appearance

The United States General Services Administration (hereinafter "GSA"), pursuant to the Rules of Practice and Procedure of the Pennsylvania Public Utility Commission ("PUC" or "Commission"), 52 Pa. Code §§ 5.61-5.76, hereby petitions for leave to intervene in this proceeding, including the right to offer testimony, cross-examine witnesses and file written briefs, at its discretion. As grounds for this petition, GSA states as follows:

1. The Federal Property and Administrative Services Act, 40 U.S.C. § 501(c) authorizes GSA to represent the consumer interests of the Federal Executive Agencies in proceedings before state regulatory bodies.
2. The Federal Executive Agencies have a substantial interest in this proceeding because they own and operate numerous buildings and facilities within Philadelphia and annually purchase millions of dollars of electricity.
3. Among other things, PECO's proposed replacement of its existing Auxilliary Rider with a Capacity Reservation Rider, proposed new billing demand ratchet for general service commercial and industrial customers, and the proposed allocation of PECO's distribution base rate increase will have direct billing impact on GSA. GSA seeks to examine the reasonableness of these proposals and resulting rates, but reserves its right to address all aspects of PECO's application. No other party can adequately represent the federal government's interests.


