Receipt is acknowledged of the Application of Zito Media Voice, LLC, for approval to provide Competitive Access Provider and Facilities-Based Competitive Local Exchange Carrier Services in the service territories of Verizon Pennsylvania, Inc, Verizon North, Inc, Windstream Pennsylvania, Inc, and Frontier Communications of Oswayo River.

Please be advised that pursuant to the Commission's June 3, 1996 Order, "Implementation of the Telecommunications Act of 1996" at Docket Number M-00960799, provisional authority is granted with respect to Competitive Access Provider Services. However, this provisional authority may be revoked if, upon further Commission review, the application is found to contain deficiencies.

Per Secretarial letter dated April 5, 2007, Provisional Authority pertaining to the Application of Zito Media Voice, LLC, to provide Facilities-Based Competitive Local Exchange Carrier Services in the service territories of Verizon Pennsylvania, Inc, and Verizon North, Inc., was revoked due to certain deficiencies found in the Application.


The application of Zito Media Voice, LLC, for approval to provide Facilities-Based Competitive Local Exchange Carrier Services in the service territory of Windstream Pennsylvania, Inc, and Frontier Communications of Oswayo River, is not eligible for provisional authority under said Order, and therefore, notice must be published in the Pennsylvania Bulletin and in a newspaper of general circulation where the Applicant intends to provide service. Accordingly, Zito Media Voice, LLC, is hereby directed to publish the enclosed notice in a newspaper of general circulation in the areas involved and file proof of publication with the Commission on or before July 6, 2007.
