MOTION FOR ADMISSION *PRO HAC VICE*

Pursuant to PUC Rule 5.103 and Rule 301 (b) of the Pennsylvania Bar Admission Rules, Kathleen Barksdale on behalf of the United States General Services Administration (hereinafter "GSA"), respectfully requests the Presiding Administrative Law Judge enter an Order granting admission *pro hac vice* to Leonard Lucas as counsel for GSA in proceedings related to the above-captioned matter. In support of this motion, GSA states as follows:

1. Pursuant to PUC Rule 1.24 (b) is considered to have entered an appearance in this proceeding and is counsel of record for GSA. The movant is an active member of the Bar of the Commonwealth of Pennsylvania (Attorney Registration No. 30620).

2. Submission of the IOLTA form and payment of the fee, under Pa Code § 301, is not required, because the Pennsylvania Public Utility Commission is not a Court as defined by Pa Code § 81.502.
