
AND NOW COMES, Talton Invision, Inc. and files its Notice of Completion of Transaction, a statement of which follows:

1. By Order entered January 16, 1998, your Honorable Commission approved, inter alia, the transfer of interexchange reseller assets from Invision Telecom, Inc. to Talton Holding, Inc. (now Evercom, Inc.) and subsequently to Talton Invision, Inc. Your Honorable Commission also approved the application of Talton Invision Inc. to operate as an interexchange reseller in the Commonwealth of Pennsylvania.

2. In a subsequent transaction deemed to be effective October 1, 1997, the assets of Invision Telecom described in paragraph one above were transferred directly to Talton Invision, Inc.
