Dear Mr. Gill,

I am writing in response to your letter of April 28, 2015 requesting further information on the above-mentioned EGS license.

Enclosed are my responses to each of your inquiries:

- 1) Summarize any outstanding tax issues you have with the Pennsylvania Department of Revenue.

AGR Group, Inc. does not have any outstanding tax issues with the Pennsylvania Department of Revenue.

- 2) Is the company going to continue to have a business presence in Pennsylvania after license cancellation? If not, has the company provided formal notification to the Pennsylvania Department of Revenue that it intends to go out of existence/withdraw from Pennsylvania for tax purposes?

AGR Group, Inc. has not had any business presence in Pennsylvania since ceasing operations on or about August 4th, 2014. Therefore, there is no intention for any further business presence in PA in the future.

We have provided formal written notification to the Pennsylvania Department of Revenue of the notice to withdraw by filing an Application for Tax Clearance Certificate on March 10, 2015 (**Exhibit A**). I was told by that Department that it will take them approximately three months to process the application.

- 3) Regarding any other issues which may create a claim on the bond or other security which you maintain for your license:
- a) Are there any outstanding or potential issues with any independent System Operator, Regional Transmission Organization or similar entity involved in the Pennsylvania retail electricity market? If yes, explain.

I am unaware of any potential issues which would fit into this category; there are none outstanding. AGR Group, Inc. was a marketer therefore did not take title to the commodity.

b) Are there any outstanding or potential issues with any entity that provides your company with electricity for Pennsylvania in the wholesale market? If yes, explain. Provide copies of all contracts, agreements or other arrangements that are involved.

As above, AGR Group, Inc. did not take title to the commodity. There are no outstanding issues.


