**MOTION FOR CONTINUANCE OF HEARING DATE**

PECO Energy Company ("PECO"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. A telephonic hearing for this matter is currently scheduled to take place on Thursday, June 11, 2015 at 10:00 a.m.
2. PECO is requesting a continuance of the June 11<sup>th</sup> hearing date because of the unavailability of PECO witness, High Bill Foreman, Thomas Lerro.
3. Mr. Lerro supervises the high bill field technician who performed the high bill field investigations at the Complainant's property. The high bill field technician, Lori Messere, has since retired from PECO. Accordingly, Mr. Lerro will testify to Ms. Messere's high bill field reports, which the company will produce at the hearing.
4. Mr. Lerro was recently hospitalized and he is not expected to return by June 11<sup>th</sup>.
5. PECO therefore respectfully requests that the hearing be continued to a further date the last week of July or in August 2015.
6. The Prehearing Order in this matter states that requests for a continuance are only granted "in rare situations where good cause exists." (Prehearing Order, citing 52 Pa. Code § 1.15).

7. PECO avers that “good cause” exists to continue the scheduled hearing to another date because one of PECO’s witnesses is unavailable.

8. PECO contacted the Complainant, Michele Jones, and she consents to the company’s continuance request.

9. PECO therefore respectfully requests that the further hearing be continued to a further date.
