**MOTION FOR CONTINUANCE OF HEARING DATE**

PECO Energy Company ("PECO"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. A telephonic hearing for this matter is currently scheduled to take place on Monday, June 29, 2015 at 10:00 a.m.
2. PECO is requesting a continuance of the June 29<sup>th</sup> hearing date because of the unavailability of PECO witness, High Bill Foreman, Thomas Lerro.
3. Mr. Lerro supervises the high bill field technician who performed the high bill field investigation at the Complainant's property. The high bill field technician, Mary McQuilkin, has prescheduled vacation on June 29<sup>th</sup>. Accordingly, Mr. Lerro will testify to Ms. McQuilkin's high bill field reports, which the company will produce at the hearing.
4. Mr. Lerro was recently hospitalized and he is not expected to return by June 29<sup>th</sup>.
5. PECO therefore respectfully requests that the hearing be continued to a further date the last week of July or in August 2015.
6. The Prehearing Order in this matter states that requests for a continuance are only granted "in rare situations where good cause exists." (Prehearing Order, citing 52 Pa. Code § 1.15).

7. PECO avers that “good cause” exists to continue the scheduled hearing to another date because one of PECO’s witnesses is unavailable.

8. PECO has made several attempts to contact the Complainant, Deree Norman to obtain his consent; however, Mr. Norman has not responded to the company.

9. PECO therefore respectfully requests that the further hearing be continued to a further date.
