

NOTE AA - A flat charge based on one hour at the applicable transportation rates shown in Columns 2 or 3 will be assessed when the distance from original point of origin to final destination is 20 miles or less.
A flat charge based on one and one-half hours at the applicable transportation rates shown in Columns 2 or 3 will be assessed when the distance from original point of origin to final destination is more than 20 miles but not exceeding 40 miles.
