The above referenced respondent has received notification from the PA PUC that a \$500.00 fine must be paid pursuant to the reasoning outlined in the letter dated 5/14/15 drafted by Secretary Rosemary Chiavetta of the PA PUC.

We are asking if the penalty can be lifted due to the following circumstances which were out of the control of Mr. Sallack:

- The Form H filing was ordered from the insurance carrier at the renewal 12/2/2013
- The insurance carrier responded to the Managing General Agent and stated that the filing was no longer required.
- The Managing General Agent then requested the filing from the insurance carrier again and specified that this is a State and not a Federal filing. To be sure they understood the request.
- The insurance carrier did not submit the appropriate filing to the PUC because the next notice received was the complaint.
- Our agency, the managing general agent and Mr. Sallack were unaware up until that point that there was any issue with the Form H. Once we were notified we immediately contacted the insurance carrier.
- The Form H filing was made 2/5/2014 and rejected by the PA PUC because the PA PUC had confused the file for Mark Sallack T/A Sallack Well Services PUC #A-00120369 with the file for Marc A Sallack Inc #A-00107119 (per Wendy Yohe's email dated 2/7/15)
- The filing was re-submitted 2/7/15 and accepted 2/12/15

We have insured Mr. Sallack since 2004 and we have never had a problem like this. He is very diligent in all of these matters and would never operate without the proper insurance and filings. Unfortunately, the insurance carrier he was with was bought out in 2014 and the transition was not smooth. This was an isolated incident that has not happened before or since and was out of Mr. Sallack's control.

Please advise if the penalty can be lifted.



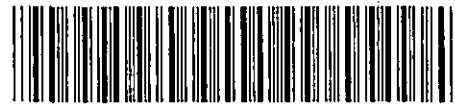

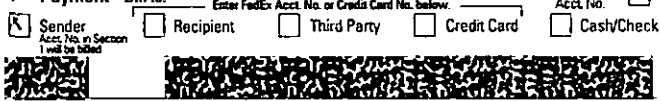
