Dear Mr. Coulter:

By Order entered December 16, 2004, at Docket Nos. A-311242 and A-311242 F0002, the Commission approved the application of France Telecom Corporate Solutions, L.L.C. (FRANCE TELCO) to provide service as a Competitive Local Exchange Carrier (CLEC) and as a Reseller of Interexchange (IXC) Toll Services to the public in the Commonwealth of Pennsylvania. The Company has filed Telephone PA PUC Tariff No. 1 and Telephone PA PUC Tariff No. 2, both with effective dates of February 11, 2005.


This letter is to notify you that the CLEC Tariff No. 1 and the IXC Tariff No. 2 have been permitted to become effective. This permission does not constitute a determination that the tariffs are just, lawful, or reasonable, but only that suspension or further investigation does not appear to be warranted at this time.

FRANCE TELCO is also directed to add its Pennsylvania tariffs to its website within thirty (30) days from the date of this letter. Upon placing the tariffs on its website, FRANCE TELCO shall contact Cyndi Page (717-787-5722; cypage@state.pa.us) of the Commission's Communications Office to inform her of the tariffs' website address. In order to maintain a true and accurate representation of its tariffs on file with the Commission, FRANCE TELCO should continually update its tariffs whenever supplemental revisions are approved by the Commission.

If FRANCE TELCO does not maintain a website, the Pennsylvania Public Utility Commission will host its tariffs on the Commission's website. Contact Cyndi Page for instructions on how to have your tariffs and/or tariff supplement(s) added to the Commission's website.

The determination to permit the tariffs to become effective is without prejudice to any complaint timely filed against the proposed tariffs.
