In response to the Telephone Hearing Notice dated April 28, 2015, I respectfully request a change the venue and time from Wednesday, June 17, 2015 at 10AM to an early afternoon, *In-Person Hearing* on a mutually convenient date and time. Three friends will be accompanying me on the drive, presumably to Harrisburg, so I can navigate getting to the hearing.

The reason I am requesting this change is to prove I have physical disabilities you would not be able to appreciate during a telephone conversation/hearing. In my Testimony regarding my unsatisfied demand that PECO remove the 'Smart Meter' their contractors deployed May 23, 2013, I will be invoking the Americans With Disabilities Act (ADA). Is there wheelchair service available in the front lobby of your building or, is there a handicap-accessible entrance? Can someone in your office please inform me of my options, and thank you?

Further, I would also like to provide you with:

1. Evidence that I didn't 'Opt-Out' but, rather, unwittingly cooperated in this human radiation experiment without informed consent until it impacted my ability to function.
2. The reason and proof for rectifying the billing discrepancies.
3. A plan for me to off-load the offensive and dangerous RF/EMF Smart Meter, which PECO refused to accept.
4. Documentation that I will have supplied to you and Counsel Shawane L Lee in advance, as per your instructions.
