In accordance with Section 252(e) of the Telecommunications Act of 1996 (the "Act"), and the Commission's interim procedures in its June 26, 2003 Tentative Order in Docket No. M-009-60799, Proposed Modifications to the Review of Interconnection Agreements, **Frontier Communications of Pennsylvania, Inc. ("FCPA")** is herewith filing an Interconnection Agreement between FCPA and **Southwestern Bell Mobile Systems, LLC d/b/a Cingular Wireless**, governing interconnection arrangements in FCPA's service area. This Agreement is submitted for Commission approval under Sections 252(e)(1) and (e)(2).

Also attached is an affidavit certifying that the attachment is a true and correct copy of the executed interconnection agreement.

The Act specifies in Section 252(e)(4) that, if a state agency does not act to approve

or reject an agreement reached by negotiation within ninety (90) days following the filing, it shall be deemed approved.






