
Absent an appropriate amendment, Protestant prays the application may be dismissed.

EXHIBIT B

RULES AND REGULATIONS

OPERATING AUTHORITY

To transport, as a common carrier, persons in paratransit service, between points in the County of Berks, and from points in said County, to points in Pennsylvania, and return.

NON-EXCLUSIVE, ADVANCE RESERVATIONS

Service will be provided on a non-exclusive basis, and reservations must be made prior to service being rendered.

COMPUTATION OF MILEAGE

Mileage shall be determined by the actual reading on the odometer of the specific vehicle used for transportation, beginning when the passenger boards the vehicle and ending when the passenger is discharged at final destination.

BAGGAGE AND EQUIPMENT

Baggage and equipment is limited to the capacity of the vehicle, and baggage and equipment will be transported at no additional charge.

WAITING TIME

Chargeable waiting time will be assessed in 15 minute increments. Carrier will hold its vehicle upon request to pick up passengers for back haul or return trip.



RULES (Continued)

CONTRACT SERVICES

Contract services provided will be for a term of not less than 30 days for prequalified persons under a federal, state, county or municipal governmental agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

CANCELLED TRIP

In the event a vehicle is dispatched for a trip, but the vehicle is not used, the base rate charge will be applied for a cancelled trip, in addition to the mileage rate from the Company's dispatch office to the point of origin of the trip.

SCHEDULE OF RATES PER PERSON

Base Rate	\$25.00
Mileage Rate (applies in addition to the Base Rate stated above) - Per Mile or fraction thereof	\$1.50
Waiting Time - Each 15 minutes or fraction thereof	\$8.00


