**INTERIM ORDER

On May 5, 2015, an evidentiary hearing was conducted in the above-captioned matter concerning the billing dispute of Lavoris Mintz (Complainant) against the Philadelphia Gas Works. IT IS ORDERED:


1. PGW late-filed exhibits marked as PGW Exhibits 5, 6 and 7 are hereby admitted into the record.
