1. On June 4, 2014, Applicant Laye Kourouma t/a Kourouma Transport and Protestant Rover Community Transport, Inc. entered into a Restrictive Amendment (“Restrictive Amendment”). A copy of the Restrictive Amendment as filed with the Pennsylvania Public Utility Commission (“Commission”) is attached as Exhibit “A”.

2. Under the Restrictive Amendment, the Application was amended so that the authority sought shall read as follows:


To transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the City and County of Philadelphia and the County of Delaware, to points in Pennsylvania, and return.

3. Based upon the approval of the Restrictive Amendment, and conditioned upon its acceptance by the Commission and any Order issued being consistent therewith, Joint Protestants agree to withdraw their Protest to the Application as amended.

4. Joint Protestants desire to remain a party of record to receive copies of any orders issued by the Commission in the proceeding.

5. If the Restrictive Amendment is not accepted by the Commission, Joint Protestants reserve the right to present evidence in opposition to approval of the Application at an evidentiary hearing.

1.       The above-captioned Application is hereby amended so that the authority sought shall read as follows:



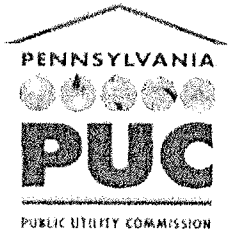
